Noise monitoring at M6 - HK Baptist Church Henrietta Secondary School was temporarily suspended from 22 February 2020 as the school is temporarily closed and refused our access due to public health concern. Monitoring will be resumed when the access to the school is resumed.

Noise monitoring at M8 - City Hall was temporarily suspended from 2 February 2020 to the end of reporting period as the City Hall was temporarily closed due to public health concern. A temporary noise monitoring point for M8 has been proposed and agreed by the IEC at the entrance of the City Hall. Noise monitoring for M8 was resumed at the temporary noise monitoring point at the entrance of the City Hall on 26 February 2020.

Due to interruption of electricity, the 24hr TSP of CMA1b, 2a, 3a, 4a, 5b, MA1e, 1w was rescheduled from 2 Feb 2020 to 3 Feb 2020.
